IMPROVEMENTS IN OUR INFRASTRUCTURE

We look forward to all that 2020 will bring – including improvements and updates to our infrastructure! **MSWD** has many projects in the design phase that are planned to begin constructing in the new year! Check them out below:

• Advanced Meter Infrastructure (AMI) Project.

The district-wide meter changeout project is under way and occurs every 15 to 20 years. This project began in Fall 2019 and is projected to be completed by June 2020. Customers will receive a letter 1-2 weeks prior to their neighborhood's installation. For more information, visit: www.mswd.org/AMI

• Terrace Reservoir Rehabilitation Project. This project will include rehab of the interior and exterior of three 2-million gallon reservoirs! There will also be updated safety features, mixing systems for better water quality, as well as site improvements to better secure the site and help with erosion of the slopes around the tanks.



- New Reservoir at Vista Reservoir Site. New construction of a second 300,000 gallon water reservoir. The addition of a second reservoir will allow for redundancy at the site and for the rehabilitation of the existing reservoir without affecting service to our customers.
- Water Pipeline Capital Improvement Program. As part of a capital improvement program, approximately 3.5 miles of water lines will be replaced. MSWD operates and maintains approximately 390 miles of potable water lines. Existing water mains vary in size, type, age and condition. Water leak history, age of pipe, type of pipe, and size and pressures will determine what sections of lines will be included in the program.

WATER BILL ASSISTANCE PROGRAM

The Help2Others Bill Assistance program helps MSWD customers pay their water bills. MSWD and its team members contribute funds annually to the Help2Others program specifically for MSWD customers.

The program offers eligible residential customers a \$50 credit on their water bill once in a 12-month period. Customers must reapply for subsequent years.

If you need help paying your water bill, you can apply with United Way of the Desert (UWD) by calling 760.323.2731. UWD screens eligible customers and provides them with assistance in paying their water bill. You may also apply online at MSWD.org.

WATER COUNTS ACADEMY: WHERE DOES OUR WATER COME FROM?

Mission Springs Water District and its CV Water Counts partners will host the 4th Annual Water Counts Academy starting February 4. Anyone interested in learning about our local water supply, history, conservation, and infrastructure is welcome to apply! The academy is held at UCR-Palm Desert over the course of four weeks and concludes on February 29 with a tour featuring a few Mission Springs Water facilities. There is no tuition or fee to participate. There will be 50 spots available this year!

Participants are required to attend the four evening classes from 5:30 to 7:30 p.m. and the Saturday tour to receive their certificate. To apply, visit cvwatercounts.com/academy


